| <p><u>ATTENDED FUNERAL (Funeral Directors charges only)</u> This is a funeral where family and friends have a ceremony, event or service for the deceased person at same time as they attend the burial or cremation</p> <p>Taking care of all necessary legal and administrative arrangements</p> <p>Collecting and transporting the deceased person from the place of death (Normally within 15 miles of the Funeral Director's premises) into the Funeral Directors care.</p> <p>Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at our chapel of rest in Acol.</p> <p>Provision of a suitable coffin – this will be made from Oak Veneered</p> <p>Viewing of the deceased person for family and friends, by appointment with the Funeral Director.
